As President and Chief Executive Officer of PartnerRe Ltd., Patrick Thiele is responsible for the strategic direction and management of the Company. He is also a Director of PartnerRe.

Under his leadership since 2000, PartnerRe has successfully transitioned from a Cat-only reinsurer to a well-diversified, global reinsurance company. With 14 office locations worldwide offering reinsurance coverage for property and casualty, catastrophe, specialty lines, life, and alternative risk products, PartnerRe's total assets are currently \$17 billion, total capital is greater than \$5 billion, and for the year ended December 31, 2008, revenues were \$4.0 billion.

PartnerRe aims to provide highly-valued products to its clients, deliver appropriate returns to shareholders, and ensure a satisfying work experience for its employees. To support this vision, PartnerRe has a culture of thoughtful and disciplined risk-assumption within pre-determined return goals. This is the foundation of PartnerRe's success.
